Barasat Unnayan Prostuti (BUP), established in 1993, is a non-profit organization dedicated to holistic community development.

Over the past 27 years, BUP has expanded its program activities to address critical issues such as human trafficking, health, education, environment, and livelihood promotion.

Certified by the Ministry of Home Affairs under FCRA and registered with NGO Darpan under NITI Aayog, BUP operates under the West Bengal Societies Registration Act.

The organization emphasizes community-based interventions and works closely with communities and government departments to empower the population to access their rights and entitlements.

BUP's primary focus is currently on combating human trafficking in the vulnerable North 24 Parganas district of West Bengal, where it has established itself as a leading entity in rescue, repatriation, and rehabilitation efforts. Additionally, the organization is involved in livelihood promotion, micro-finance initiatives, community-based healthcare, education programs, and environmental sensitization as part of its comprehensive approach to community development.

Barasat Unnayan Prostuti is actively involved in anti-trafficking initiatives, child marriage prevention, universal education, mitigating school dropouts, skills development for adolescent girls and women, and the formation of self-help groups to support women's livelihoods. The COVID-19 pandemic has underscored the importance of our environmental programs, emphasizing the need for effective waste management and extensive plantation efforts.

We have been engaged in these programs for many years, but the challenges posed by the COVID-19 crisis and the destruction caused by Cyclone Amphan have highlighted the necessity of expanding our activities. We would like to express our heartfelt gratitude to our partners and stakeholders who have supported us throughout this journey. We eagerly anticipate their continued cooperation in the future.

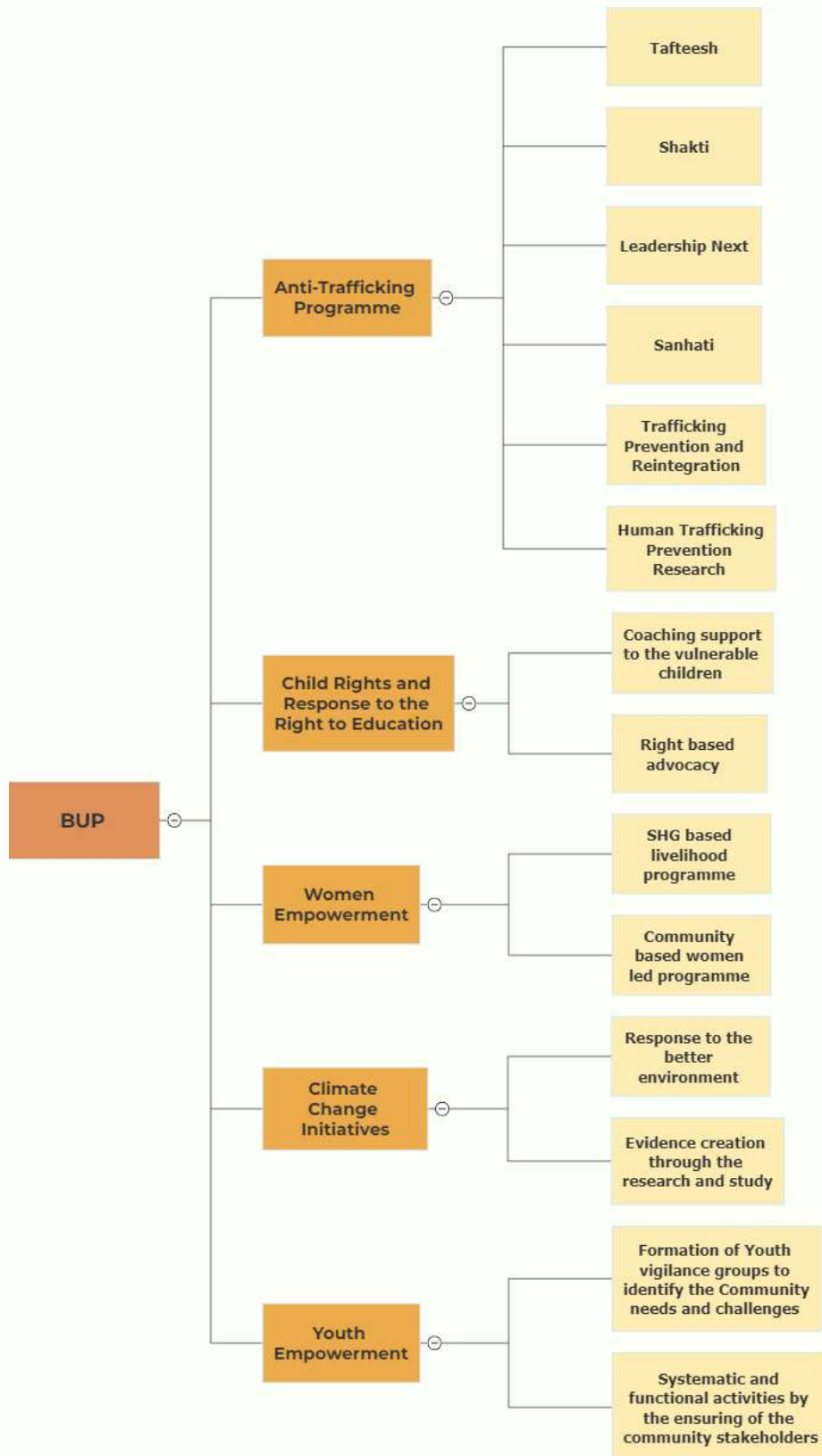

Programme at a glance



Sanhati (Strengthening Community based Safety Net Programme)

This program, initiated in 2018 and ongoing, aims to establish a safety net within the community to combat the rising issue of human trafficking, with a particular focus on protecting adolescent girls. The problem of human trafficking has persisted in all Development Blocks of North 24 Parganas, but we have pinpointed Amdanga and Gaighata Blocks for intervention. Initially, we selected two highly vulnerable Panchayats, Beraberia and Sutia, for intervention. However, we have since expanded our efforts to include two more vulnerable Panchayats, Bodai and Shimulpur, in our intervention activities.

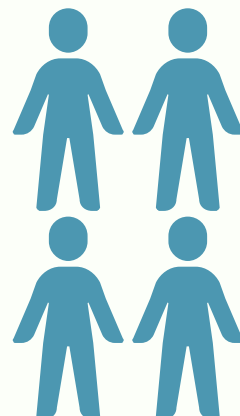
Programme Coverage

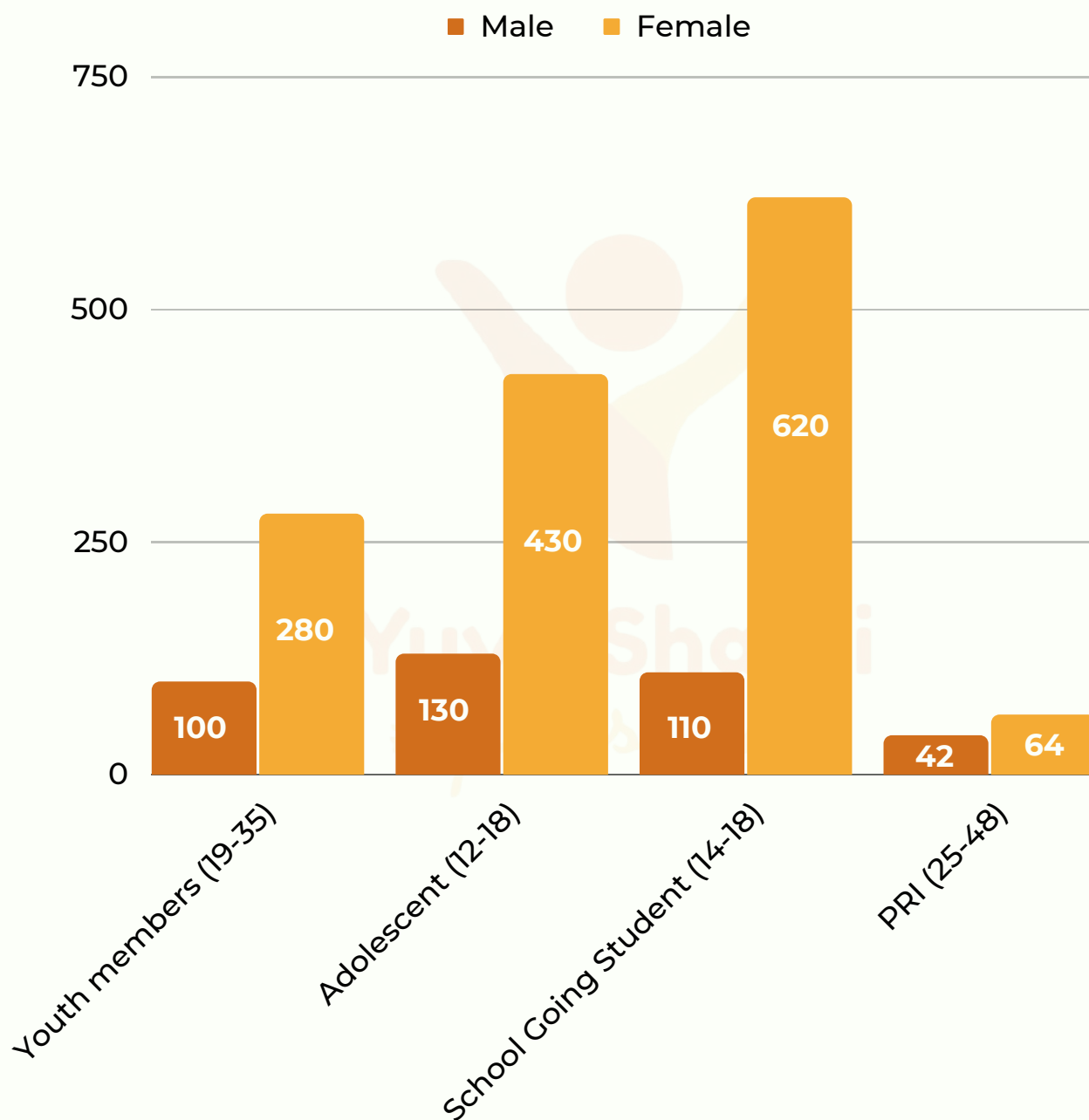
The wider coverage of the project has been able to reach out to more than 1,25,000 populations across the four Panchayats.

Tafteesh- In search of Justice (Anti-Trafficking Program)

Since 2004, Barasat Unnayan Prostuti (BUP) has been dedicated to combating human trafficking through its collaborative network known as Partners for Anti Trafficking (PAT). Within this network, BUP serves as the secretariat organization, overseeing a comprehensive Anti Trafficking program spanning across 18 blocks within the north 24 districts. The primary objective of this program is to establish a sustainable ecosystem that safeguards the rights of survivors of human trafficking. In its role as the implementing partner, BUP places significant emphasis on fostering leadership among survivors themselves, empowering them to take the lead in managing the Anti Trafficking ecosystem.

The Tafteesh Anti Trafficking program operates along five key dimensions:



Dimension of Tafteesh

Rescue

The initial step in this rights-based case management is rescue and support. BUP collaborates with strategic partner organizations like Rescue Foundation and Mission Mukti Foundation to rescue survivors and facilitate their reintegration into society. This reintegration process adheres to a Community-Based Rehabilitation (CBR) approach.

Rehabilitation

After successfully reintegrating survivors into their communities, the rehabilitation phase begins. This phase involves identifying instances of rights violations through the use of CIT (Case Intake Tools). Periodic CIT reviews are conducted every six months to assess the status of activities related to rights violations.

Prosecution

This dimension is a crucial aspect of rights-based case management. It encompasses activities such as procedural corrections, victim compensation processes, strategic litigation, and strengthening the system, including engagement with Anti-Human Trafficking Units (AHTU). BUP has assumed a leadership role in managing interstate cases within the North 24 Parganas district.

Leadership

A central goal of the Taftesh program is to empower survivors by creating spaces for their leadership. Consequently, survivor collectives like Utthan and Bijoyini have been established and are actively working to amplify the collective voice of survivors.

Prevention

Over time, it has become evident that preventing trafficking crimes requires a collective approach. The prevention model adopted by BUP primarily focuses on creating a community-level safety net. This is achieved through the strengthening of Panchayati Raj Institutions (PRI) and block-level government mechanisms, fostering a collective effort against trafficking.

In summary, Barasat Unnayan Prostuti has been diligently working on its Anti Trafficking program since 2004, aiming to create a sustainable ecosystem that safeguards the rights of survivors. Through its various dimensions of rescue, rehabilitation, prosecution, leadership empowerment, and prevention, BUP is actively combatting human trafficking and advocating for a safer, more just society.



Activities Performed



First Aid Counseling Support

BUP offered first aid counseling to survivors, identifying and referring those in need of psychiatric treatment, with 8 receiving expert care from Dr. Gautam Saha.



Legal Case Management

BUP assisted survivors in legal matters, collaborating with social workers, facilitating joint case planning, attending hearings, and aiding in obtaining case documents.



Procedural Correction

Critical procedural improvements were made, leading to court-ordered AHTU investigations and reinvestigations in select cases.



Interstate Case Management

BUP coordinated interstate cases in North 24 Parganas, advocating for video conferences and acting as a bridge between lawyers and survivors through social workers.



System Strengthening

BUP focused on enhancing the responsiveness of AHTUs and DLSA, conducting advocacy efforts to improve service accessibility for survivors.



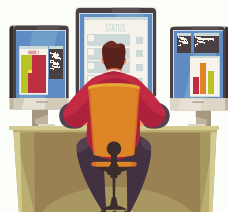
Monitoring Mechanism Strengthening

BUP prioritized monitoring mechanism enhancement, enabling social workers to design their monitoring tools, empowering survivors to create their tools.



Communication Strategy and Media Visibility

BUP finalized its communication strategy, increasing media presence, especially on platforms like Facebook and Twitter, contributing to brand building.



Taftesh MIS Engagement

BUP actively participated in developing the Taftesh MIS interface, offering capacity-building support for an effective system.



Partner Capacity Building

BUP supported block partners in aligning with the Taftesh Strategic Plan, providing technical assistance, aiding in the design of monitoring and advocacy plans, and improving digital reporting and time management.

Outcomes Achieved

Enhanced Access to Free Legal Aid Service

In the past year, there were no rejections of applications for free legal aid service, a marked improvement in system responsiveness, encouraging trafficked survivors to seek access to justice.

Improved Efficiency of DLSA Lawyers

DLSA lawyers demonstrated increased efficiency, evident in their active engagement in sub-divisional courts, filing Narazi petitions, protest petitions, participating in trials, and significantly, handling victim compensation cases.

Victim Compensation Success

A total of 23 cases received victim compensation, with the highest award of 8 Lac at the Bongaon sub-divisional level. DLSA lawyers played a leading role in processing VC applications, and the increased filing of VC applications reflects improved system responsiveness.

Interstate Case Management Awareness

Creating a platform for sharing plans increased survivors' awareness of interstate case management, fostering a sense of accountability. Currently, BUP is involved in 14 interstate cases.

■ Strategic Litigation Impact ►

Collaborating with the Tafteesh Lawyer Team, BUP achieved a significant order for compensation, securing 8.50 lac from the High Court. The court's directive to process the VC amount within seven days demonstrated the program's efficacy.

■ Efficient Digital Reporting ►

Implementation of the digital reporting system allowed social workers to submit timely reports through Microsoft Word. Adoption of the Tafteesh MIS interface increased data recording engagement.

■ Negotiation Capacity ►

BUP enhanced its negotiation skills through the Tafteesh program, successfully negotiating with Tafteesh lawyers on fees without external support, indicating growth in leadership capabilities.

■ Improved Visibility ►

BUP developed a self-centric visibility measuring tool, improving its capacity to use social media platforms effectively. This tool also benefited block partners in enhancing their social media capacity.

Leadership Next (Anti-Trafficking Program)

This program, formerly known as the Survivors' Leadership Program (SLP) since 2018, focuses on fostering individual and collective leadership. During the SLP phase, staff from mentoring organizations and trafficked leaders collaboratively acquired knowledge on various facets of leadership, including leadership styles. Survivors gradually transformed into leaders through this program, with mentoring organizations providing continuous support. In 2021, the program's mode and strategy underwent changes to further nurture leadership development, resulting in its current name, "**Leadership Next.**"

Goal for 2025

- By 2025, the BUP aims to establish self-identity, leadership, and competency by building capacities in resource mobilization, proposal writing, and networking. The goal is to secure at least two new funders for the Leadership Next program.
- Support will be provided to collective members and partners to actively participate in combating human trafficking. This will be achieved by leveraging effective media visibility, skill development, self-empowerment, and campaigns by 2025.
- By 2025, the BUP plans to establish a meaningful and effective monitoring and escalation mechanism for the Leadership Next program, ensuring the participation of collectives, partners, and the project management unit.
- By 2025, all members of the BUP will increase their ability to handle crisis management and mental health issues independently in cases of office-related mental health problems and other crises.

► Achievements, Innovations, and Energizers ◀

■ Enhanced Skills and Capacities ►

The Secretariat underwent comprehensive training, acquiring skills in monitoring, evaluation, social media, outcome harvesting, technical report creation, and conflict resolution. This growth energized the team, encouraging proactive engagement.

■ Strengthened Relationships ►

Through open discussions, escalations, and debates, the Secretariat established individual identities, fostering a robust leadership-centric and escalation management system. Energized by improved teamwork, members embraced their roles with enthusiasm.

■ Financial Literacy Impact ►

The financial literacy program exceeded expectations, illuminating the leaders' need for awareness and alternative livelihood support. The program also underscored the importance of securing their rights to access government schemes and services, boosting team motivation.

■ Crisis Management Effectiveness ►

The Secretariat observed partner proactiveness during crisis management, adapting its support accordingly. This innovative approach proved effective, energizing both the team and partners.

■ Team Bonding and Identity ►

Monitoring meetings, facilitated by Kamo, provided insights into leadership, role dynamics, accountability, and team cohesion. These lessons energized the Secretariat, reinforcing the importance of forming a unified team identity.

■ Learning Application ►

These achievements demonstrate the team's commitment to setting realistic objectives, monitoring financial literacy, fostering partnerships, and promoting team engagement. The Secretariat's capacity to adapt, learn, and grow has been a driving force behind these accomplishments.

◀ Transformational Leadership Journey in One Year ▶

Over the past year, the 'Secretariat team' within the BUP consortium embarked on a transformative journey, evolving from a budding concept to a cohesive and dynamic unit. Initially tasked with developing individual proposals, reports, and monitoring processes, the team gradually forged a distinct identity both within the consortium and in collaboration with external partners. This journey also saw a deliberate effort by each team member to cultivate their leadership skills, yielding positive outcomes recognized by the BUP consortium and funding partners.

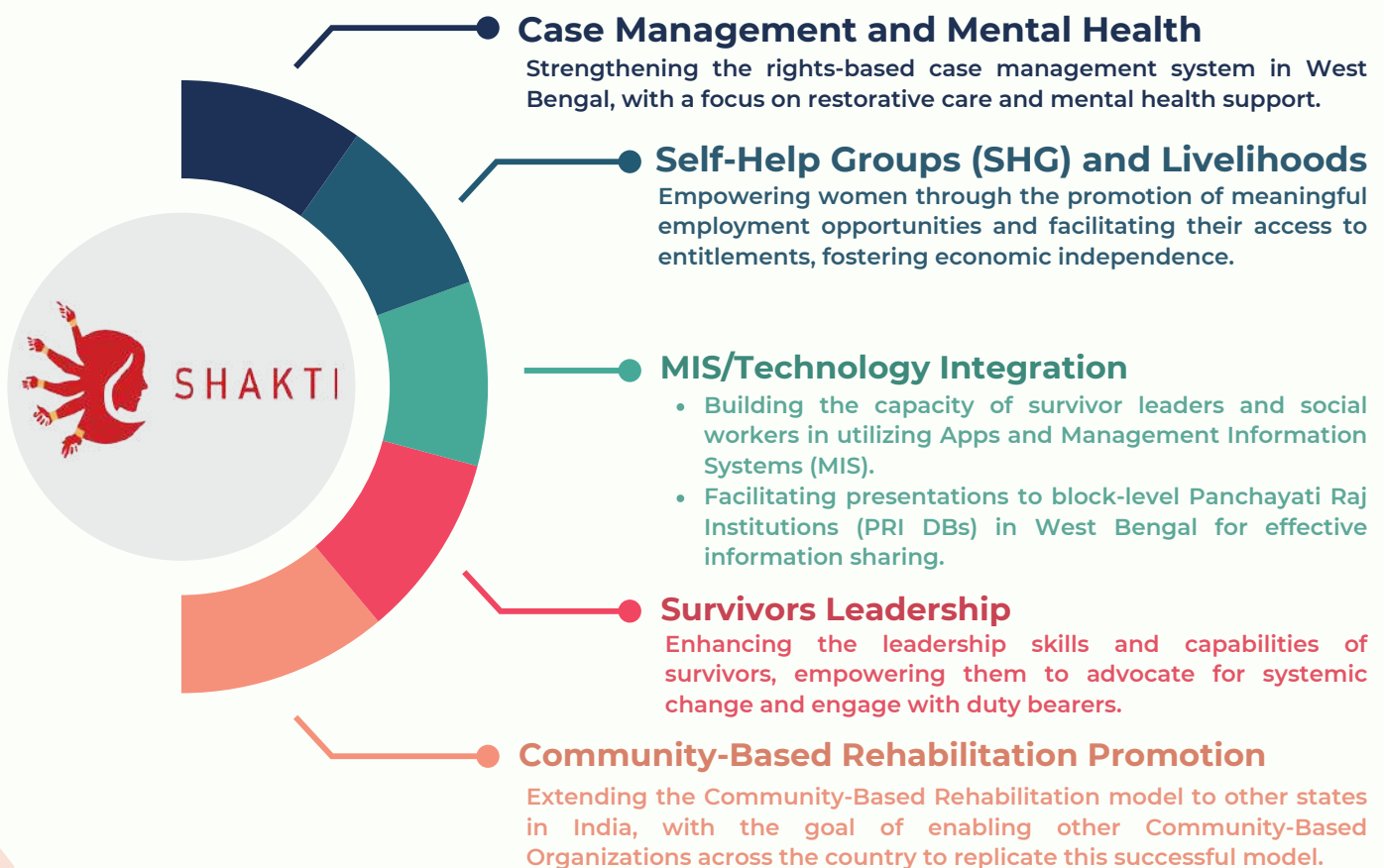
At the outset, there was some ambiguity regarding the concept of leadership among team members, with many equating it solely with the Leadership Next (LN) program and mistakenly conflating LN with other initiatives. Some assumed that all LN project responsibilities rested on the LN coordinator's shoulders, leaving others uncertain about their own leadership roles within the team. However, the past nine months brought clarity as team members began to realize their varying degrees of responsibility across proposals, reports, and impact assessments. This newfound awareness kindled a sense of individual leadership within the team.

As team members started to grasp their unique leadership contributions, they also embraced a collaborative spirit, supporting one another's endeavors. The program manager and documentation officer introduced teamwork, transitioning from the coordinator's brainstorming sessions to peer-supported report and proposal writing. Open discussion meetings in recent months provided a platform for members to voice their concerns, aspirations, and visions for the Secretariat team. These discussions fostered a shared understanding, clarified roles, and addressed underlying fears and discomfort, ultimately leading to a palpable shift in the team's mindset marked by newfound positivity and a deeper appreciation of multifaceted leadership.

Shakti (Anti-Trafficking Program)

The Shakti Project, launched through a collaboration between the non-governmental organization Sanjog and BUP, is a comprehensive program aimed at tackling the trafficking of women and girls for commercial sexual exploitation. Its primary objectives encompass preventing trafficking, safeguarding survivors, and facilitating their complete rehabilitation and successful reintegration into society.

SANYUKT MIS System

Sanjog, in collaboration with Barasat Unnayan Prostuti (BUP), has developed an innovative Management Information System (MIS) known as "Sanyukt." This system is designed to streamline and improve the case management process, particularly focusing on tracking and supporting the rehabilitation of survivors.

Currently, 20 social workers operating across 18 blocks in the North 24 Parganas region utilize the Sanyukt mobile app on provided smartphones to effectively manage and maintain data related to the case management and recovery of 160 survivors. Additionally, four team members have assumed roles as MIS Sub-Centre Coordinators, providing essential support in the form of training, data auditing, tutorial video creation, and more to their peers.

An important advancement this year is the implementation of CIT Digitization, which entails a shift towards a paperless Case Intake Tool (CIT) system. This significant change aims to reduce time, printing costs, and the utilization of human resources, ultimately making the case management process more efficient and environmentally friendly.

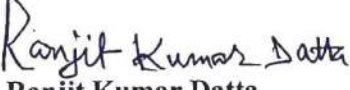

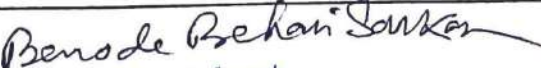
